 - (c) Licensee may not modify the Font without explicit permission of Licensor.
- (d) Licensee shall not have the right, in any circumstance, to re-distribute, license, convey, sell or transfer the Font via any method or medium, including, without limitation online, digitally or physical discs and the rights granted to Licensee are specifically contingent on Licensee using the Font for personal use. Such use shall not extend to Commercial use.
- (e) For the avoidance of doubt the Celldweller Name, Word Mark and Logo are registered Trademarks of Celldweller Productions. Any use of the Font to create the Celldweller WordMark/Logo are only for Personal, non-commercial use.
